### 1. Scope

This Privacy Policy applies to information, including information that may be used, either alone or in combination with other information, to personally identify an individual or household (“personal information” or “personal data”), collected and used by Canadian Solar Inc. and its affiliated companies and subsidiaries (collectively, “Canadian Solar” or the “Canadian Solar Group”). This Privacy Policy applies to information we collect on our websites and in email, text, and other electronic messages between you and Canadian Solar. It does not apply to information collected by us offline or through any other means, including on any other website operated by a third-party, or collected by us or any of our affiliates or subsidiaries related to your or any other individual's employment or potential employment, or collected by any other third-party, including through any application or content (including advertising) that may link to or be accessible from our websites.

Please read this Privacy Policy carefully to understand our policies and practices regarding your information and how we will treat it. If you do not agree with our policies and practices, your choice is not to use our websites. By accessing or using our websites, you agree to this Privacy Policy; however, if you are based in the EU, when you use our website or interact with us electronically as described herein, you may need to authorize Canadian Solar to process your personal data within the scope of this Privacy Policy. This Privacy Policy may change from time to time (see [Changes to this Policy](#) for terms around notification of changes to this policy).

### 2. Data Controller, Data Protection Officer, and Representative

Canadian Solar is the data controller of your personal data. Canadian Solar has

appointed a Data Protection Officer in compliance with applicable laws, as well as a representative in the European Union in compliance with the General Data Protection Regulations. Canadian Solar, its Data Protection Officer, or its representative may be contacted in any manner set forth below in section 14 of this privacy notice.

### 3. Information collected by Canadian Solar

Canadian Solar collect data and information about you such as name, surname, company, contact details, email, your request data, and any other data you provide us and /or that will be needed to install our business relationship. We also collect information that is about you but does not directly identify you, such as your IP address, traffic data, location data, logs, referring/exit pages, date and time of your visit to our websites, error information, clickstream data, other communication data, the resources that you access and use on the websites, and other information about your internet connection and the equipment you use to access our websites. Canadian Solar collects data from a variety of sources, including:

- Information we collect from you directly via email, phone, letter, fax and any other means;
- Information we collect about you when you call us, visit our sites, use our mobile applications or services, or view our online advertisements;
- Information we collect about you from other sources, such as commercially available sources;
- Information we collect automatically as you navigate the website through cookies, web beacons, and other tracking technologies.

Most of the personal data we collect from you is required to enter into a contract with Canadian Solar, for Canadian Solar to perform under the contract, and to provide you with our products and services and the information you request. You have the right to opt out of certain information handling practices by contacting our Data Privacy Officer at the contact information set out at the end of this Privacy Policy. However, please note that if you refuse to provide such personal data or withdraw your consent to our processing of personal data (when appropriate), then in some cases we may not be able to enter into the contract or fulfill our obligations to you under it. Further, any withdrawal of consent from information processing activities applies on a go-forward basis and does not apply to information processing activities which have been previously agreed to.

#### 4. Use of data

All the information Canadian Solar collects about you may be combined to improve our communications with you and to develop world-class products and services.

Canadian Solar will use the information collected to:

- provide the products and services you request (newsletter, guarantee on products, quotations, offers etc.);
- evaluate our potential or existing commercial relationship and your ability to perform the contract based on our legitimate interest to do so;
- subject to below, conduct marketing and sales activities (including generating leads, pursuing marketing prospects, performing market research, determining and managing the effectiveness of our advertising and marketing campaigns and managing our brand);
- operate, evaluate and improve our business (such as by administering, enhancing and improving our products and services; developing new products and services; managing our communications and customer relationships; performing accounting, auditing, billing, reconciliation and collection activities);
- to carry out our obligations and enforce our rights arising from any contracts entered into between you and us;
- to notify you about changes to our websites or any products or services we offer;
- maintain and enhance the safety and security of our products, services, network services, information resources and employees;
- in any other way we may describe to you when you provide the information, and for which we obtain consent;
- for any other purpose for which you provide it or with your consent.

Where required by applicable law, Canadian Solar will obtain your consent for the processing of your personal information for direct marketing purposes.

The legal basis for Canadian Solar processing your personal information as described above will typically be one of the following:

- **Your consent.** By using our website or, under applicable laws, where you are offered the option to consent, selecting the relevant tick box, you consent to our collection, use, and sharing of your personal data for the purposes of conduct marketing and sales activities as described in this Privacy Policy. You can opt-out at any time, free of charge and without prejudice to the lawfulness of processing based on consent given before revocation, as set forth below in section 7 of this privacy notice.
- **Performance of a contract with you or where you are a relevant party.** We process your personal data in order to fulfill our obligations to you pursuant to our contract with you or with you as a relevant party and to deliver our goods and services to you;
- **Our legitimate business interests.** Our legitimate interests are balanced against your interests and rights and freedoms and we do not process your personal data based on our interests if your interests or rights and freedoms outweigh our legitimate interests. Our legitimate interests are to: facilitate communication between Canadian Solar and you; detect and correct bugs and to improve our websites; safeguard our IT infrastructure and intellectual property; detect and prevent crime; promote and market our business (provided that in certain jurisdictions this may apply solely to services similar to those you have purchased from us) and to develop our products and services; or
- **Compliance with our legal obligation.** We may also process your Personal Data when we are required or permitted to by law; to comply with government inspections, audits, and other valid requests from government or other public authorities; to respond to legal process such as subpoenas; or as necessary for us to protect our interests or otherwise pursue our legal rights and remedies (for instance, when necessary to prevent or detect fraud, attacks against our network, or other criminal and tortious activities), defend litigation, and manage complaints or claims.

If you have an account with us, we will retain your personal data for the entire time that you keep your account open, or otherwise deleted or destroyed in accordance with applicable laws. Otherwise, or after you close your account, data will be retained by Canadian Solar only for a period as it may be considered necessary according to applicable laws and reasonable business practices. This may also include keeping your personal data on our

backup and disaster recovery systems in accordance with our backup and disaster recovery policies and procedures. For data that have been rendered anonymous in such a manner that you are no longer identifiable, we may keep such information indefinitely.

#### 5. Disclosure of Data to Third Parties

Canadian Solar does not sell your information for monetary consideration or otherwise disclose personal information about you except as described here or at the time of collection.

- Canadian Solar may share personal information within the Canadian Solar Group for the purposes described in this Privacy Policy.
- Canadian Solar implements the Meta Pixel on the website to collect information about your activity and interactions with the website. The Meta Pixel helps us measure the effectiveness of our advertising by tracking actions such as page views, clicks, and purchases. This data helps us better understand user behavior, optimize our marketing campaigns, and serve you more relevant advertisements across Facebook and Instagram. - Canadian Solar also uses Google Analytics to track and analyze traffic and usage patterns across the website. Google Analytics collects information about how you use our website, including your IP address, browser type, device type, and the pages you visit. This data is used to help us improve the user experience, content, and functionality of our website. For more information on how Google Analytics collects and processes data, please refer to Google's Privacy Policy: <https://policies.google.com/privacy>.
- Canadian Solar may share personal information with service providers Canadian Solar has retained to perform services on our behalf (such as payment processing, order fulfillment, and customer support). These service providers are contractually required to safeguard the information provided to them under terms substantially equivalent to those of this Privacy Policy and are restricted from using or disclosing such information except as necessary to perform services on our behalf or to comply with legal requirements.
- Canadian Solar may share personal information with our joint marketing partners and other business partners for the purposes described in this Privacy Policy, and if you agree to share the data with them.

- Canadian Solar may share personal information about you to a buyer or other successor in the event of a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of its assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by Canadian Solar about our customers is among the assets transferred.

\* Canadian Solar may also disclose personal information about you (1) if we are required or permitted to do so by applicable law or legal process (such as a court order), (2) to law enforcement authorities or other government officials to comply with a legitimate legal request, (3) when we believe disclosure is necessary or appropriate to protect the rights, property, or safety of a member of the Canadian Solar Group, our customers, or others, (4) to establish, exercise or defend our legal rights, (5) in connection with an investigation of suspected or actual fraud or illegal activity, (6) to fulfill the purpose for which you provided it, (7) for any other purpose disclosed by us when you provided the information, or (8) otherwise with your consent.

## 6. Data Transfers

Canadian Solar may transfer the personal information Canadian Solar collects and store such data in other countries, including China, Canada and the U.S., which may have materially different data protection laws than the country in which the information was provided, including the rights of law enforcement and other government authorities in those foreign jurisdiction to access, use and disclose your personal information for purposes not contemplated herein.

If we transfer your personal information to a foreign jurisdiction, we will transfer the personal information only for the purposes described in this Privacy Policy subject to the caveats above. To the extent required by applicable law, when we transfer your personal information to recipients in other countries, we will take adequate measures to protect that information. Where required by law, we use data protection agreements between Canadian Solar and all other recipients of your data that include, where applicable, the Standard Contractual Clauses adopted by the European Commission as providing an adequate level of protection for personal data. You may request a copy of the applicable data protection agreement by contacting us through the contact information below.

## 7. Your rights

Applicable data protection laws may provide you with certain rights with regards to

our processing of your Personal Data. These may include:

- **Access, Update and Rectification.** You can review and change your personal data by contacting us through the Contact Information below of any changes or errors in any personal data we have about you to ensure that it is complete, accurate, and as current as possible. We may also not be able to accommodate your request if we believe it would violate any law or legal requirement or cause the information to be incorrect.
- **Restrictions.** You have the right to restrict our processing of your personal data under certain circumstances. In particular, you can request we restrict our use of it if you contest its accuracy, if the processing of your personal data is determined to be unlawful, or if we no longer need your personal data for processing but we have retained it as permitted by law.
- **Portability.** To the extent the personal data you provide Canadian Solar is processed based on your consent and that we process it through automated means, you have the right to request that we provide you a copy of, or access to, all or part of such personal data in structured, commonly used and machine-readable format. You also have the right to request that we transmit this personal data to another controller, when technically feasible.
- **Withdrawal of Consent.** Solely to the extent that our processing of your personal data is based on your consent, you may withdraw your consent at any time by closing your account. Withdrawing your consent will not, however, affect the lawfulness of the processing based on your consent before its withdrawal, and will not affect the lawfulness of our continued processing that is based on any other lawful basis for processing your personal data.
- **Right to be Forgotten.** You have the right to request that we delete all of your personal data. If you have an account, we cannot delete your personal data except by also deleting your user account, and we will only delete your account when we no longer have a lawful basis for processing your personal data or after a final determination that your personal data was unlawfully processed. We may not accommodate a request to erase information if we believe the deletion would violate any law or legal requirement or cause the information to be incorrect. In all other cases, we will retain your personal

data as set forth in this policy. In addition, we cannot completely delete your personal data as some data may rest in previous backups. These will be retained for the periods set forth in our disaster recovery policies.

- **Complaints.** You have the right to lodge a complaint with the applicable supervisory authority in the country you live in, the country you work in, or the country where you believe your rights under applicable data protection laws have been violated. However, before doing so, we invite you to contact us directly in order to give us an opportunity to work directly with you to resolve any concerns about your privacy.
- **How You May Exercise Your Rights.** You may exercise any of the above rights by contacting us through any of the methods listed under Contact Information below. If you contact us to exercise any of the foregoing rights, we may ask you for additional information to verify your identity. We reserve the right to limit or deny your request if you have failed to provide sufficient information to verify your identity or to satisfy our legal and business requirements. Please note that if you make unfounded, repetitive, or excessive requests (as determined in our reasonable discretion) to access your personal data, you may be charged a fee subject to a maximum set by applicable law.

The state or other jurisdiction you live in may provide you with additional rights regarding our use of personal data, including the right to receive additional information about our collection and use of your personal data. To learn more about any additional rights or to receive any additional information that may be applicable to you as a resident of one of these states or jurisdictions, please see the privacy addendum for your state or jurisdiction that is listed below and is attached to this Privacy Policy.

### **Your U.S. State Privacy Rights**

Depending on your U.S. state of residence, you may have additional privacy rights with respect to your personal information. These rights may be accorded to you pursuant to, respectively, the California Consumer Privacy Act; the California Privacy Rights Act; the Colorado Privacy Act; the Connecticut Personal Data Privacy and Online Monitoring Act; the Oregon Consumer Privacy Act; the Texas Data Privacy and Security Act; the Utah Consumer Privacy Act; the Virginia Consumer Data Protection Act; the Montana Consumer Data Privacy Act; Nevada's SB 220; the Delaware Data Protection Act; the Iowa Data

Protection Act; the Nebraska Data Privacy Act; the New Hampshire Privacy Act; the New Jersey Data Privacy Act; the Tennessee Information Protection Act; the Minnesota Consumer Data Privacy Act; the Maryland Online Data Privacy Act; the Indiana Consumer Data Protection Act; the Kentucky Consumer Data Protection Act; the Rhode Island Data Transparency and Privacy Protection Act; the Oklahoma Consumer Data Privacy Act (effective January 1, 2027); and the Alabama Personal Data Protection Act (effective May 1, 2027) (collectively, as may be amended from time to time, “US Data Privacy Laws,” and together with GDPR, “Data Privacy Laws”). For the purposes of this section, personal information shall have the same meaning as “personal data” as such term is used under US Data Privacy Laws.

- **Requests to Know:** You have the right to request that we disclose:
  - The categories of personal information we have collected about you;
  - The categories of sources from which we have collected personal information about you;
  - Our use of the personal information we have collected about you;
  - The business or commercial purposes for selling or collecting personal information about you;
  - The categories of personal information sold, shared, or disclosed about you, as well as the categories - and, if you are a resident of Oregon or Colorado, the names - of third parties to whom the personal information was sold, by category of personal information for each party to whom personal information was sold; and
  - The specific pieces of personal information collected about you for the twelve (12) months prior to the date of your request.

The delivery of our response to your request to know may take place electronically or by mail. We are not required to respond to requests to know more than twice in a twelve (12)-month period.

- **Requests to Delete:** You have the right to request that we delete any personal information about you that we have collected from you and retained, subject to certain exceptions. We may deny your deletion request if retaining the personal information is necessary for us or our service provider(s) to:
  - Complete the transaction for which we collected the personal information, provide a good or service that you requested, take actions reasonably anticipated within the context of our ongoing business relationship with you, or otherwise perform our contract with you;
  - Detect security incidents, protect against malicious, deceptive, fraudulent, or illegal activity, or prosecute those responsible for such activities;
  - Debug products to identify and repair errors that impair existing intended functionality;

- Exercise free speech, ensure the right of another consumer to exercise their free speech rights, or exercise another right provided for by applicable law;
  - Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when the information's deletion may likely render impossible or seriously impair the research's achievement, if you previously provided informed consent;
  - Enable solely internal uses that are reasonably aligned with consumer expectations based on your relationship with us;
  - Comply with an obligation under applicable law; and/or
  - Make other internal and lawful uses of that information that are compatible with the context in which you provided it.
- **Right to Opt-Out of the Sale or Sharing of personal information:** You have a right to opt out of the sale or sharing of personal information we have collected about you to third parties. If you exercise this right, we will not sell or share personal information about you. **Please note that Canadian Solar does not “sell” or “share” your personal information as such terms are defined under U.S. Data Privacy Laws.**
  - **Requests to Correct Inaccurate Personal Information:** You have the right to request that we correct inaccurate personal information that we maintain, or which pertains to you. Upon receipt of a verifiable request from you, we will use commercially reasonable efforts to correct the inaccurate personal information.
  - **Right to Opt Out of Profiling:** You have the right to opt out of “profiling.” This opt out applies to the automated processing of personal information that is used to render decisions that could have a legal or similarly-significant effect on a user. Examples of such decisions include those related to credit and access to fundamental goods or services. **Canadian Solar does not engage in profiling as described above.**
  - **Right to Non-Discrimination:** You have the right not to be discriminated against for the exercise of your US Data Privacy Laws rights described above. Unless permitted by US Data Privacy Laws, we will not as a result of such exercise:
    - Deny you services;
    - Charge you different prices or rates for services, including through granting discounts or other benefits, or imposing penalties;
    - Provide you a different level or quality of services; or
    - To the extent applicable, suggest that you may receive a different price or rate for goods or services or a different level or quality of services.

### **Authorized Agents**

You may designate an authorized agent to make requests on your behalf. You must provide

an authorized agent written permission to submit a request on your behalf, and we may require that you verify your identity directly with us. Alternatively, an authorized agent that has been provided power of attorney may submit a request on your behalf.

### **Methods for Submitting Consumer Requests and Our Response to Requests**

Canadian Solar reserves the right to verify all requests made pursuant to US Data Privacy Laws. Upon receipt of such request, we may ask you for additional information to verify your identity. Any additional information you provide will be used only to verify your identity and not for any other purpose. We will acknowledge the receipt of your request within ten (10) days of receipt. Subject to our ability to verify your identity, we will respond to your request within forty-five (45) days of receipt. To protect your privacy and the security of personal information about you, we verify your request by requesting additional identifying information that will only be used to verify your identity and for no other purpose.

If you are a resident of Colorado, Connecticut, Delaware, Iowa, Maryland, Minnesota, Montana, Nebraska, New Hampshire, New Jersey, Oklahoma, Oregon, Tennessee, Texas, or Virginia, you may appeal our denial of your request pursuant to your US Data Privacy Law rights. To do so, you must email us at [privacy@canadiansolar.com](mailto:privacy@canadiansolar.com) within forty-five (45) days of your receipt of our denial therefor. We will respond to an appeal within sixty (60) days of receipt for residents of Connecticut, Delaware, Iowa, Maryland, Montana, Nebraska, New Hampshire, Oklahoma, Texas, Tennessee, and Virginia, and within forty-five (45) days of receipt for residents of Colorado, Minnesota, and New Jersey, and Oregon.
